

License Agreement for DoomsDay USB: The Survival Tech Toolkit

This License Agreement (“Agreement”) is a binding agreement between you, the user (“User”), and **DoomsDay.Media** - <https://doomsday.media> (“Creator”). By using the DoomsDay USB: The Survival Tech Toolkit (“Device”), you agree to the terms and conditions set forth in this Agreement. If you do not agree to these terms, do not use the Device.

1. License Type

The DoomsDay USB: The Survival Tech Toolkit is provided under a **Freemium License**. This means that the Device includes a base set of free features, while additional features or functionality may require separate licensing or payment.

2. Open Source Software Notice

The Device contains software, operating systems, manuals, material and programs that are based on or derived from **open source software**. All open source software is licensed under their respective licenses, which are provided within its documentation.

The Creator is not the owner of these open source components and provides no warranties regarding their operation, fitness for a particular purpose, or compatibility.

3. Disclaimer of Liability

3.1 Experimental Nature:

The Device is provided as an **experimental toolkit**, and the User acknowledges that its use may involve risks, including but not limited to system crashes, data loss, hardware malfunctions, or security vulnerabilities.

3.2 No Warranty:
